 - a. Solar Screening Requirements (all sites) Defer until Jeff Holmes is available.
 - b. Act 143 & On-Farm Businesses The Commission discussed the additional regulations for farms and residential development that will make it harder for new development, noting that newer generations seem to relocate to denser areas rather than wanting to build in the community. The additional regulations make it harder and harder for landowners to do what they want with the land.
- 3) Energy Compliance Procedure LCPC Review & Substantial Deference Motion by Vicki to pursue a preliminary assessment by LCPC of the 2017 Municipal Plan to determine if the new requirements for substantial deference are met. Seconded by Zac. Voting: 5 in favor, 0 against, motion passed.

 - a. **VT Natural Resource Council** \$1,500 grant Awarded; Kate Lalley to Assist coming to Jan PC
 - b. **VT Arts Council –** Submitted Dec. 10th with HPES, Green Mountain Technical Carrer Center and Vermont Studio Center to hire an artist to develop the Hyde Park Trailhead site with art and history elements \$15,000.
 - **c.** Lake Champlain Basin Program "Net Zero" Application Submitted 11/27; Decision 02/19 at \$50,000 for soil testing and designs along Main Street,
- 5) North Hyde Park Village Center Redevelopment The Historic Sites Committee is pursuing community support for redevelopment of the Grange and the Northern Boarders Regional Planning Commission for funding.
